Safety Policies:

Masks: The NYS Governor has mandated that all students and staff are required to attend school with a mask. All students and staff are encouraged to wear masks while indoors throughout the day, to the best of their ability.

- Once the mandate is lifted, we will not require the students or staff to wear masks.
- Masks will not be required while outdoors.
- Masks are required on buses as required by the DOE.

Vaccinations: Please find attached a letter from the NYC Department of Health including a flier stating the “Top Ten Reasons to Get Vaccinated Against COVID-19” developed by the **Jewish Orthodox Women’s Medical Association (JOWMA)**, **Chevra Hatzalah** and the NYC Department of Health and Mental Hygiene. We recommend you review the information closely. We encourage all those eligible to get vaccinated. All our efforts are needed to finally defeat this virus.

Though not mandatory, it is important that we know if your child is vaccinated. We ask that you respond by completing the attached survey and returning it to us via email.

Exposure to Covid: If your child contracts Covid, they must quarantine for 10 days and may return to school the following day once they are symptom free without the use of medication.


If your child is exposed to Covid in the home your child will need to quarantine for 5 days from the day of exposure and present a negative PCR test after day 5 if they have **not** been vaccinated or do **not** have antibodies or have **not** had Covid within the past 90 days. Without the presentation of a negative test your child will need to quarantine for the full 10 days.

Travel: We will follow all state guidelines in place regarding travel protocols in place during the time of travel.


School Trips: Please note that some trips/activities may require proof of vaccination. This will be determined by the site providing the services. Any child who cannot provide proof of vaccination will not be able to fully participate. We will do our best to avoid such situations.

Visitors in the Building: All visitors to the building will be required to wear a mask at all times. We believe this practice will increase the safety and security of our students and staff.
